•Localism Act: Enables 6 Environment Strategies to become 1 London Environment Strategy


•GLA Act: LES must cover environmental, social and economic purposes, health and health inequalities, sustainable development and climate change met through Integrated Impact Assessment

-The Mayor shall consult the Assembly, functional bodies, London boroughs (LBs), City of London and any other person or body considered appropriate

-LES must include Biodiversity, Municipal waste management, Climate change, Energy, Air quality, Noise + general assessment of environment.

An integrated environment strategy – Good Growth

- In the context of COP21 and Population Growth
- Delivery on key manifesto commitments Zero Carbon by 2050, Air Quality, National Park City, Waste and Water
- In an integrated manner e.g. AQ and Health, Energy and Fuel Poverty, Growth in Green Economy


