Mayor of London M6- requested further information

As requested, the information provided in Annexes A and C of NLP/EX/03 The Mayor's responses to the Panel's Preliminary Questions (Mayor of London September 2018), and in the Mayor of London's matters statement M6 Consultation and Engagement has been re-formatted categorised under the relevant descriptors provided by S.32 (3) (a)- (d) of the GLA Act 1999. This is provided in Annexes A-D of this paper.

At the hearing session on Tuesday Section 32 of the GLA Act was discussed in relation to consultation and engagement for the London Plan. However, following legal advice, we would like to clarify that this provision relates to the general power of the authority and not to the production of the spatial development strategy. The specific provisions for public participation for the spatial development strategy are set out 335 of the GLA Act. However, even if S 32 is the appropriate consultation test, we have complied with it because we have engaged with these groups in any event as set out below.

Section 32 of the GLA Act states:

- (2) In determining what consultation (if any) is appropriate under subsection (1) above, the bodies which, and persons whom, the Authority considers consulting must include-...
 - (c) bodies of each of the descriptions specified in subsection (3) below.

(3) Those descriptors are-

- (a) any voluntary bodies some or all of whose activities benefit the whole or Part of Greater London:
- (b) bodies which represent the interests of different racial, ethnic or national groups in Greater London;
- (c) bodies which represent the interests of different religious groups in Greater London:
- (d) bodies which represent the interests of persons carrying on business in Greater London.

The information provided in Annex B of NLP/EX/03 The Mayor's responses to the Panel's Preliminary Questions (Mayor of London September 2018), and in the Mayor of London's matters statement M6 Consultation and Engagement, (the annexes in both documents are identical) contains information on Local Plan and Opportunity Area Planning Framework Meetings and highlights engagement undertaken and collaboration specifically between GLA Officers and borough Officers. Given the fact that meeting attendees were limited to just GLA and borough Officers, it has not possible to categorise these meetings under S32. (3) (a)- (d) above.

Note: this is not an exhaustive list. A number of non-London Plan team organised events took place which members of the London Plan team attended. In addition, meetings took place throughout the GLA, for example, on Wednesday 28th March a

meeting took place between the Mayor, Jules Pipe DM, Keith Prince AM and Imam representatives to discuss the subject of Muslim burial sites.

Consultation also took place on other Mayoral strategies which has fed into the London Plan, via the GLA's strategy co-ordination group, and other sections of the GLA assisted with the dissemination of details of the London Plan consultation to ensure it was as comprehensive and wide ranging as possible.
